





## UCD Critical Edits Phase 3A Have Transitioned to Critical/Fatal

May 1, 2023

Fannie Mae and Freddie Mac (the GSEs) are announcing new resources to assist with the Uniform Closing Dataset (UCD) critical edits Phase 3A and 3B transition from warning to critical/fatal. The Phase 3A edits transitioned to critical/fatal on **May 1, 2023, and** Phase 3B will transition to critical/fatal on **Nov. 6, 2023**. Please reference the <u>April 11 announcement</u>.

## UCD Critical Edits Phase 3B

More than half of the Phase 3 edits were included in Phase 3A subset, which transitioned to critical today, May 1. The GSEs delayed a smaller group of the high-firing Phase 3 critical edits to Phase 3B with a Nov. 6 transition date to give lenders, third-party originators, and software partners/Technology Solution Providers (TSPs) more time to analyze and resolve problematic data. All Phase 3B edits are currently available for testing in the GSEs' respective production UCD collection systems and customer testing environments.

**Note:** A few additional edits have moved to Phase 3B to further align edits between the GSEs; refer to the *Revision Log* tabs in the Joint GSE UCD Phase 3 Critical Edits Feedback Message Mapping Document and the UCD Critical Edits Matrix for details.
