★ The morning after Business Day (BD) 1, the 4 a.m. run is replaced by processing next cycle transactions (if applicable). This run includes all next cycle activity reported on BD1 prior to 10 p.m.

### Exceptions

Here are a few exceptions to the daily processing times:

- No 4 a.m. run
- No processing runs
- Only the 4 a.m. run occurs on the first Saturday of the month
