Loan Selling Advisor® Release Notes provide updates on enhancements to help you streamline the way you work.

## Cash-Specified Payup

### Effective January 26, 2026

The following two new cash-specified payups for 30-year fixed rate mortgages will apply to both Mandatory and Best-Efforts Executions:

- Low Loan Balance \$375K (Max LLB <= 375,000)
- Low Loan Balance \$400K (Max LLB <= 400,000)

You'll see the new cash-specified payup when you generate a Cash Rate Sheet or take out a Cash Contract in Loan Selling Advisor and when you submit a request through either our Cash Pricing or Cash Committing application programming interfaces (APIs).

## View Evaluation Issues Updates

### Effective January 26, 2026

The View Evaluation Issues screen will be updated to improve system stability, resiliency, speed to market and overall performance.

Key changes include:

- Updated search and results screens
- Introduced new search criteria:
  - Loan Created Date Range
  - Loan Evaluation Issues Date Range
  - Early Funding Indicator
  - Loan Amortization Type

## ULDD Revisions

### Effective January 1, 2026

The following updates were added to the Uniform Loan Delivery Dataset (ULDD) Revisions webpage:

- October 1, 2025 – Added conditionality details and implementation notes for Co-Issue XChange® where All-In Funding is enabled.
- November 20, 2025 – Updated conditionality details for *Other Funds Collected At Closing Amount* (Sort ID 157).

## Coming Soon

### Guarantor Contract Enhancements

**February 23, 2026**

Loan Selling Advisor will be redesigned to simplify and improve the following Guarantor Contracting workflows:

#### Take Out Guarantor Contract (Manually)

- Request Price screens will be redesigned and renamed to Take Out Guarantor Contract.

#### Import Guarantor Contract

- Import a Guarantor Contract using the new icon button. (The upload import file will be available when the User clicks on Take Out Guarantor Contract.)

#### Contract Details (View and Modify)

- The Contract Details screen will be refreshed and renamed Guarantor Contract Details.

#### Guarantor Contract Pipeline Search

- The Contract Pipeline Search screen will be redesigned and renamed Search for Guarantor Contract.
