## Effective October 27, 2024

We're adding a new message to provide documentation requirements when the borrower has indicated that they are employed by an interested party to the transaction or family. This message also supports the recent policy update announced in *Single-Family Seller/Servicer* Guide <u>Bulletin 2024-10</u>.

We will also begin **defaulting the self-employment indicator** to either true or false if not provided in the LPA submission. This new defaulted indicator will apply to all LPA submissions as of October 27. The indicator will be defaulted to true when self-employment income is provided or if the ownership interest is >25%. Otherwise, the indicator will be defaulted to false.
