# **Hybrid Appraisal Messages**

#### Effective April 6, 2025

To support the expansion of hybrid appraisals, as announced in *Single-Family Seller/Servicer Guide* (Guide) <u>Bulletin</u> <u>2025-1</u>, we're making the following updates:

# **Employment Representation & Warranty Messages**

#### Effective April 6, 2025

In April, we'll release LPA specification version 6.0.00 and will introduce a new indicator shield to help you quickly identify employment representation and warranty (R&W) relief eligibility. The new indicator shield is only available if you adopt LPA v6.0.00. For all valid specification versions, we're adding the following new loan-level messages to indicate employment R&W relief eligibility.
