We're updating Loan Closing Advisor® warning and critical edit feedback messages to help you prepare for the transition of critical edits for the Uniform Closing Dataset (UCD) Phase 3B Postponed and Phase 4 warning edits and for UCD v2.0 adoption. We're also removing certain messages.

Updates to Existing Feedback Messages

Effective October 27, the following updates to existing text messages for UCD v1.5 and v2.0 will be implemented in Loan Closing Advisor:

Message Code	Former Message Text	New Message Text
CRIT0090	Lender Credits must be delivered in the Total Closing Costs Section.	IntegratedDisclosureSubsectionType ="LenderCredits" is missing. This data point and value must be provided with IntegratedDisclosureSectionType ="TotalClosingCosts".
CRIT0093	The tolerance cure amount must be provided when the Lender Credits amount is not \$0.	LenderCreditToleranceCureAmount is missing. This data point must be provided and be greater than or equal to "\$0" for IntegratedDisclosureSubsectionType = "LoanCostsSubtotal".
DQC1657	A Borrower-Paid payment amount At Closing is required for the Other Costs Subtotals subsection.	IntegratedDisclosureSubsectionPaymentAmount is missing for IntegratedDisclosureSubsectionPaymentTimingType = "AtClosing". This data point must be provided and be greater than or equal to "\$0" for IntegratedDisclosureSubsectionType = "OtherCostsSubtotal".
DQC1658	A Borrower-Paid payment amount Before Closing is required for the Other Costs Subtotals subsection.	IntegratedDisclosureSubsectionPaymentAmount is missing for IntegratedDisclosureSubsectionPaymentTimingType = "BeforeClosing". This data point must be provided and be greater than or equal to "\$0" for IntegratedDisclosureSubsectionType = "OtherCostsSubtotal".
DQC1650	The closing costs subtotal paid by the borrower at closing is required.	IntegratedDisclosureSubsectionPaymentAmount is missing for IntegratedDisclosureSubsectionPaymentTimingType = "AtClosing". This data point must be provided and be greater than or equal to "\$0" for IntegratedDisclosureSubsectionType = "ClosingCostsSubtotal".
DQC1651	The closing costs subtotal paid by the borrower before closing is required. This data point must be provided and be greater than or equal to "\$0" for IntegratedDisclosureSubsectionType = "ClosingCostsSubtotal".
DQC2107	A summary with the combination of Total Other Costs section and Other Costs Subtotal subsection is required.	IntegratedDisclosureSubsectionType ="OtherCostsSubtotal" is missing. This data point and value must be provided with IntegratedDisclosureSectionType ="TotalOtherCosts".
DQC140	The combination of the Total Loan Costs section and the Loan Costs Subtotal subsection is required.	IntegratedDisclosureSubsectionType ="LoanCostsSubtotal" is missing. This data point and value must be provided with IntegratedDisclosureSectionType ="TotalLoanCosts".

Logic Update to Existing Feedback Messages


Effective October 27, the logic for critical messages CRIT0061 and CRIT0062 will be updated to include refinance transactions:

Message Code	Message Text
CRIT0061	The Due From Borrower at Closing section is required and the total amount must be greater than or equal to \$0.
CRIT0062	"The Paid Already By Or On Behalf Of Borrower At Closing section is required and the total amount must be greater than or equal to \$0."

Removing Feedback Messages

Effective October 27, the following critical and warning messages will be removed from Loan Closing Advisor for UCD v2.0:
