Loan Closing Advisor February 11, 2022 Release

Freddie Mac announced on January 20, 2022, that the values provided for the following required Qualified Mortgage (QM) datapoints would be checked for reasonableness in Loan Closing Advisor®. The edit revisions are important because inaccurate information provided in these datapoints may prevent a loan from being eligible for sale to Freddie Mac. The revisions are noted in bold in the *New Feedback Message Column*.

The following changes were implemented on February 11, 2022:

- Change to Critical and Warning Messages The updated edits to the following QM datapoints will deploy as warning messages and the message codes have been revised accordingly. These edits were due to become critical on February 11, 2022. In order to give industry additional time to prepare, we decided not to make them critical at this time; however, these DQR warning edits will transition to critical in the future.
- <u>Critical Edit Message Language</u> As shown in the table below, both the Warning and Critical Edit
 Messages are the same. The critical edit will continue to fire as it does today, and when it does, ONLY
 the non-bolded portion of the message is applicable for now. You will receive the warning message if
 the value delivered does not meet the requirements shown in **bold**.

• Revised Critical Message - Revisions were made to the following existing edit and critical message.

 New Warning Message - The new warning edit and message is a reminder to check data accuracy for Regulation Z Total Calculated Points and Fees Amount before submitting the Uniform Closing Dataset (UCD) XML file prior to delivery. The new warning message is important because if inaccurate information is provided it may prevent a loan from being eligible for sale to Freddie Mac.
