

## Loan Closing Advisor February 22, 2023 Release

Effective February 22, 2023, we're adding, removing and making updates to Loan Closing Advisor<sup>®</sup> feedback messages for Uniform Closing Dataset (UCD) Critical Edits Phase 3.

### New Feedback Messages

These new feedback messages support the correction made to editing the value delivered for total recording fees and address an issue when a loan has an escrow account, but the account is not funded at closing.

### Message Staying Warning

The following message, which fired when the signs EscrowMonthlyPaymentAmount and EscrowItemActualPaymentAmount did not match, will remain as a warning message and will NOT transition to critical on May 1, 2023:
