Refreshed UCDP User Interface

Freddie Mac and Fannie Mae (the GSEs) are excited to announce the June 14, 2025, release of the refreshed Uniform Collateral Data Portal® (UCDP®) user interface (UI). The new UI is designed to enhance the overall user experience and streamline navigation within UCDP. This update introduces several improvements and removes some outdated features for a more intuitive and efficient experience. Here's what you'll see:

Refreshed UI look and feel

- Enhanced Home page with Appraisal Search feature
- Streamlined Appraisal Submit and Search webpages
- Simplified User Preferences, Account Self Care pages and Help options

Removal of outdated features

- Appraisal Sharing through the UCDP UI
- Redundant UI functionality
- Obsolete Reports and Report features

Appraisal Sharing retirement

June 13, 2025, is the last day to use the Appraisal Sharing feature through the UCDP UI. The GSEs are retiring the feature due to infrequent use, and in alignment with our ongoing efforts to improve and streamline our services.

UCDP UI users who have Lender CorrAgg and Correspondent Agent user roles will no longer be able to navigate to and access specific Share Appraisal webpages within the UCDP UI. This includes the Share Appraisal Navigation tab with drop-down options for Share Appraisals and Retrieve Appraisals, as well as the Share Appraisal icon that appears on the Home page for these specific roles.

NOTE: UCDP direct integration (DI) users will continue to have the option to share and retrieve appraisals through the DI interface. This feature will be retired in the DI interface at a later date; the GSEs will provide advance notice when that happens.

Correspondent lenders can share the results of the appraisal submission using the Document File ID and Aggregator Identifier. Aggregators, in addition to retrieving status, findings, and the Submission Summary Report (SSR) through the DI interface, will maintain the ability to set up and modify their Aggregator Setup through the Account Administrator drop down in the UCDP UI.
