Payoffs and Payments Warning Messages

Loan Closing Advisor has certain messages that are triggered based on datapoints in the Payoffs and Payments section of the Closing Disclosure. This job aid includes messages applicable for refinance transactions using the Closing Disclosure Alternate Form. These messages transitioned to critical as part of the UCD Critical Edits Phase 1 implementation on July 31, 2021.

- CRIT0040: The total Payoffs and Payments amount is required for loans prepared using the Alternate Disclosure form.
- DQC629: A warning edit will be received for refinance loans prepared using the Model Disclosure form when the total Payoffs and Payments amount is missing.
 - The information in the Payoffs and Payments section is required for all loans.
 - The heading and the total amount for Line K. Total Payoffs and Payments (Form Field ID 25.2.1) is required. A value of \$0.00 must be provided if no liabilities are being paid off with the refinance transaction (no liability line items exist).
- CRIT0038: A liability type is required and must be a valid enumeration in the Payoffs and Payments section.
 - When using the Alternative Form, the Payoffs and Payments section is required.
 - o If the value provided for the Total Payoffs and Payments amount (Form Field ID 25.2.1) is not equal to zero, one or more liability line items must be provided and sum to the Total Payoffs and Payments amount. Liability types must be one of the following enumerations:



- CRIT0039: A description for the 'Other' liability item type is required.
 - If the value provided for LiabilityType = "Other,", then LiabilityTypeOtherDescription must be provided with a succinct description of the liability.
- CRIT0037: Indicate if the liability submitted in the Payoff and Payments section is secured by the subject property.
 - The LiabilitySecuredBySubjectPropertyIndicator must be provided with the value "true" or "false" for each liability type.

Note: If there are no Payoffs and Payments (i.e. property being refinanced is owned free and clear) only Line K. Total Payoffs and Payments (Form Field ID 25.2.1) is required.
