We're continuing to modernize Loan Coverage Advisor® with improved speed, security and business resiliency.

As a result of our tool release on July 30, 2021, you can now track COVID-19 related impacts to selling representation and warranty relief across your portfolio, including:

- Guide Bulletin 2020-28 approved & eligible payment deferral remedy for natural disasters.
- Ineligible payment deferral remedy if provided outside of disasters such as COVID-19.

In addition, nondelinquent forbearances doesn't impact relief.
